April

- Coordinator Survey for Mid-Year Progress Report due (for those campuses that participated in Compact Service Corps in the 11-12 grant year).

May

- Colorado Campus Compact membership dues/fee for AmeriCorps participation sent to campus presidents.

End of July/Beginning of August
