

2013-2014 MUA/P and/or Rural Designation by State

Medically Underserved Areas (MUAs) ~ may be a whole county or a group of contiguous counties, a group of county or civil divisions or services, or a group of urban census tracts in which residents have a shortage of personal health services.

Medically Underserved Populations (MUPs) ~ may include groups of persons who face economic, cultural or linguistic barriers to health care.

Rural ~ definition based on Office of Mangement and Budget metro and non-metro counties.

* For those Members who are serving in the counties listed below, they will need to serve at nonprofit or government sites that meet the following healthcare site placement criteria: 50% or more of clients/patients served are eligible for Medicaid services.
