I acknowledge receipt of the NOTICE REGARDING BACKGROUND INVESTIGATION AND A SUMMARY OF YOUR RIGHTS UNDER THE FAIR CREDIT REPORTING ACT and certify that I have read and understand both of these documents. I hereby authorize the obtaining of "consumer reports" and/or "investigative consumer reports" at any time after receipt of this authorization and, if I am accepted in the program, throughout my service. To this end, I hereby authorize without reservation, any law enforcement agency, administrator, local, state or federal agency, institution, school or university (public or private), information service bureau, employer, or insurance company to furnish any and all background information (including, but not limited to, driving and/or motor vehicle records, employment history, salary information and reference, drug and alcohol tests) requested by EBI and/or Accurate Biometrics acting on behalf of Compact Service Corps. I agree that a facsimile ("fax") or photographic copy of this Authorization shall be as valid as the original.

In connection with my service with AmeriCorps and participation in the Compact Service Corps Program, I hereby authorize the Compact Service Corps Coordinator ..... (NAME) at ..... (CAMPUS) to conduct a criminal history check on my behalf through justone.ebiinc.com, nsopr.gov and/or Accurate Biometrics. I understand that my ability to serve as a Compact Service Corps AmeriCorps Member is contingent upon the results of the criminal history check. I understand that failure on my part to consent to the review will result in the cancellation of my enrollment in the Compact Service Corps AmeriCorps Program.

I understand that an FBI criminal history record search is required for participation in the Compact Service Corps AmeriCorps Program; I voluntarily permit the Compact Service Corps Coordinator to forward the results of any FBI criminal history record search to Employment Background Investigations, Inc. (EBI), P.O. Box 629, Owings Mills MD 21117 for electronic storage.

If a pre-existing criminal history check was authorized by your academic program, Colorado Campus Compact may be approved to use these results as your AmeriCorps criminal history check. If this applies to me as a Compact Service Corps Member, and the funder requests a copy of the pre-existing check completed through my university/college, then I authorize the release of the results.

I understand that the information provided above is truthful and accurate to the best of my knowledge and that knowingly providing false information or omitting information may result in my removal from the Compact Service Corps AmeriCorps Program.
